

AGREEMENT FOR ADMISSION TO PRIMARY LEVEL HALF-DAY
(Hours 8:30-11:45)

I hereby agree for my daughter/son _____ to be admitted to Ivy League Montessori School for the 2011/2012 School Year.

REGISTRATION FEE (Non-Refundable)

An annual registration fee of \$100.00 per child is due with the signed agreement. This fee is non-refundable.

MATERIALS FEE (Non-Refundable)

A \$75.00 materials/supplies fee per student will be due with your agreement. Therefore, you will not be required to buy communal supplies (paper towels, scissors, crayons, etc.) for the primary classrooms. This fee does not include: classroom snacks, your child's individual supplies needed (book bags, lunch boxes, etc.) fees for field trips, testing, or other special events throughout the school year.

ENROLLMENT DEPOSIT (Refundable)

A \$500.00 enrollment deposit is due per family upon acceptance. This deposit can be rolled over upon re-enrollment. Otherwise, this deposit will be returned to you at the end of the school year in May, provided you have not terminated your agreement with ILMS before the end of the school year. The only acceptable causes of termination of your agreement are:

LOSS OF EMPLOYMENT

*TRANSFER OUT OF THE AREA (Must be at least 25 miles from ILMS)

DEATH OF A FAMILY MEMBER

Documentation will be required for any of the above circumstances for reimbursement of the Enrollment deposit.

*NOTE: School may return all or a portion of said enrollment deposit at its sole discretion, but is not obligated to do so, upon demonstrated proof (i.e. a utility bill) showing that Client has moved since the date of enrollment to a location at least twenty-five (25) miles from school.

*** TUITION SCHEDULE**

Annual tuition: \$6600.00
\$5,964.00 (sibling)

NOTE: Once the school has received tuition payments, those payments become non-refundable.

Please note: Should your child turn 5 during this school year, he/she will move up into the Full-Day program. With this move, there will be an increase in your monthly tuition installment. Please contact the office one month prior to your child's 5th birthday to confirm the additional amount.

Once your child has moved up to the Full-Day program, he/she will be eligible to participate in class Field Trips. You will be informed about all upcoming field trips and fees.

_____ Tuition is payable in twelve (12) monthly installments of \$550.00/\$497.00 (sibling amount). **The first installment is due on June 1, 2011. The last installment is due on May 1, 2012.**

_____ **For new families who enroll their child after July 31, 2011, the monthly tuition installment will be \$660.00/\$596.00 (sibling amount) per month.**

All tuition installments are due and payable by the **first day of each month**. Any amounts due under this agreement, which **are not paid by the 5th of the month, shall be assessed a \$30.00 late fee**. Furthermore, interest shall accrue on any payments more than thirty (30) days past due at the rate of 2% per month until paid in full. Additionally, in the event any money owed to the School are collected by or through the legal system, all costs of collection, including 15% of the principal and interest of said amount owed hereunder as legal fees, shall be paid by Parent. **All tuition fees are subject to change.**

Fees may be increased whenever appropriate, with a thirty day notice.

All new students are subject to a four -week trial period. If the School determines during the trial period that it is best that the child wait to attend at a later date, or an educational alternative is recommended, then a refund, where applicable, will be mailed to Parent within 30 days.

The School shall have the right to dismiss the Student upon the occurrence of any of the following:

- a. Repeated disciplinary problems by the Student.
- b. The School determines that the Student requires a different educational environment, which is more suited to his/her developmental and educational needs.

Note: The Enrollment Deposit will be refunded if termination is due to above circumstance.

Student transcripts shall not be released by the school, until all outstanding tuition and fees as set in this agreement have been paid.

I, the Parent, hereby accept these terms of the enrollment of my child at Ivy League Montessori School for the 2011/2012 school year. I understand that I am liable for the School Year's tuition upon acceptance and placement. **I understand that I will forfeit the Enrollment deposit should I terminate this agreement for any other reason other than those described.**
